NOTICE IS HEREBY GIVEN THAT We, M/S Frontier Home Developers Pvt. Ltd. ('Company') has been granted license bearing no. 88 of 2008 dated 07.05.2008 ("License") from the Directorate of Town and Country Planning, Chandigarh, Haryana (DTCP) to develop a residential group housing on the land admeasuring 13.7437 acres, situated at Sector 80 District Gurgaon.
