

PUBLIC NOTICE

Whereas, M/s. Oasis Buildhome Pvt. Ltd. (**'Company'**) is in process of undertaking the development of a Group Housing in Sector 88A & 89A, Gurgaon over an area measuring (13.759 +0.925)-14.684 acres in accordance with the provision of Licence no. 85 of 2013 dated 10.10.2013 and 151 of 2014 dated 05.09.2014 granted by Director General, Town & Country Planning, Haryana, Chandigarh.

And whereas, the company proposes to build Tower 5 (New) in place of originally planned Towers-4 & 5. The Company does not intend to construct Towers-11 & 12 as originally planned. The Company has also shifted the location of the Nursery School which was originally proposed to be constructed in Parcel D. The Nursery school will now come up in place of Towers-11 and 12 in Parcel-C.

The Company also proposes to develop a new Tower 4 in Parcel D. The Company also proposes to construct a Convenient Shopping-3, Community Building-3 for Tower-4. In addition, revisions have also been proposed in EWS Block.

And whereas, all of the above changes have been approved "in principle" by the DGTCP on 12.04.2018.

And whereas, the company has not made any revision in Towers 1,2,3(A),3(B),3(C),6,7,8,9,10, Community Building-1, 2, convenient Shopping-1, 2.

And whereas, as a pre-condition for allowing such revisions in the Building Plan, the office of Director General, Town & Country Planning, Haryana Chandigarh requires the Company to ascertain if there are any objections to the revision of Building Plan.

Accordingly, vide this public notice objections are hereby invited from the allottees on the proposed revisions to Building Plan of the said Towers/colony. A copy of the earlier approved Building Plan bearing Memo no. ZP-959/SD(BS)/2014/ 7130 dated 09.04.2014 and the revised Building Plan "IN Principle" bearing memo no. ZP-959/SD(BS)/2018/11823 dated 12.04.2018 is available for perusal on our website www.Godrejproperties.com. The said Building Plan can also be perused at the office of undersigned at UM House, Plot No. 35P, Sector-44, Gurgaon as well as in the office of Senior Town Planner, HUDA Complex, Sector-14, Gurgaon.
